

| Section 551.074 | For the purpose of considering the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee or to hear complaints or charges against a public officer or employee. |
| Section 551.076 | To consider the deployment, or specific occasions for implementation, of security personnel or devices.   |
| Section 551.084 | For the purpose of excluding witness or witnesses from a hearing during the examination of another witness.   |

- (a) the open meeting covered by this notice upon reconvening or this public meeting, or


